# PROGRAM SUMMARY CDC COVID-19 Health Disparities Grant

#### **Key Impacts:**



This program successfully identified elements that constitute barriers for specific populations and communities when accessing health information and redesigned materials based on recommendations from both subject matter and design experts to remove these impediments. Advanced Care Planning documents are now available to Arizonans in multiple formats, following accessibility best practices. These include materials in "easy-to-read and plain" language, braille, recorded audio, and recorded video in American Sign Language with closed captioning options in Diné, Spanish, and English.





### **Advance Care Planning**

#### **Program Description:**

This program revised AzHHA's advance care planning (ACP) program documents to ensure that they are accessible as well as culturally and linguistically appropriate for use in educating underserved communities in rural Arizona, particularly those with chronic health conditions who experience acute or long-term effects of COVID-19 and who may be at high risk for COVID-19 complications, morbidity, and mortality

#### **Program Goals:**

 Increase awareness of Advanced Care Planning (ACP).



- Increase the successful access and utilization of ACP forms.
- Increase the submission of completed ACP forms to Contexture, administrator for the Arizona Healthcare Directives Registry (azhdr.org)

#### **Milestones:**

- Collaborated with the Foundation for Blind Children to create templates for several braille documents related to advance care planning: Prehospital Medical Directive "DNR"; AZ Living Will and MPOA/MHOA Short Form; National POLST Form (AZ Version).
- Redesigned and updated AzHHA documents to better incorporate accessibility design principles: ACP: Advance Care Planning – 5 Steps and ACP: Questions for Your Provider.
- Contracted with a healthcare attorney group and partnered with Contexture to create a sample ACP policy for Arizona hospitals.
- 211 community members received accessible ACP educational materials directly; these were then accessed by countless others via multiple dissemination methods including social media, webpages, and radio.
