## The Impact of Licensure Compacts on Telehealth

- Telehealth is generally considered rendered at the physical location of the patient.
- Interstate compacts simplify licensing by allowing providers to practice across state lines with a valid home-state license.
- Compacts are a key tool for enabling out-of-state practitioners to deliver care across state lines.



7 healthcare interstate compacts have been adopted by more than half of US States and Territories.





#### Summary of Steps to Obtain Interstate Medical Licensure Compact (IMLC) Member State Medical Licenses Using The IMLC Service

- 1. Hold a full, unrestricted medical license in an IMLC member state that can serve as a State of Principal License (SPL)
- 2. Obtain a Letter of Qualification (LOQ) from the Medical Board in your SPL
- 3. Apply for licenses in other IMLC member states via the IMLC
  - a. Pay required fees to IMLC and fees to each IMLC member state that you are applying for a license from
  - b. Submit fingerprints to designated criminal justice agency in their SPL for a criminal background check
- 4. Receive medical licenses from each of the IMLC member states that have approved your application.
- 5. Provide any additional information required by each state you have received a medical license from.

Notes: IMLC does not provide medical licenses; IMLC provides an expedited process to obtain medical licenses from IMLC member states; IMLC maintains a database of IMLC applicants and physicians that includes disciplinary information.

#### Summary of the Nurse Licensure Compact (NLC) Multistate License

- 1. Issued to eligible nurses (RNs, LPNs, and LVNs) in their primary state of residence (PSOR) that is also an NLC member state.
- 2. Nurses with an NLC multistate license can practice in any of the NLC member states
  - Nurses must know and follow the laws and rules of the state(s) that they practice in
- 3. An NLC member state has the power to remove privileges for a nurse to practice in that state
- 4. Disciplinary actions against a nurse practicing via privileges afforded by the NLC are reported to the nurse's PSOR. Their PSOR Nurse License Board may also take disciplinary actions
- 5. License and disciplinary information of all RNs, LPNs, and LVNs is stored in a national nurse database called Nursys.

# Arizona's Telehealth Provider Registration

#### HB 2454 – Effective 1/1/2022

- Established a telehealth provider registration process for out-ofstate providers
- Allows out-of-state healthcare providers to register with AZ's applicable health care provider regulatory board or agency that licenses comparable health care providers in this AZ on an application prescribed by the board or agency.

#### **Key Features of the Registration Process**

- Eligibility
- Standards of practice
- Registrations
- Compliance with all applicable AZ laws and rules
- Liability insurance
- Patient protections
- Consent to AZ jurisdiction

### **Medicare Telehealth Flexibilities (MTFs)**

MTFs were first implemented in 2020 in response to COVID-19 PHE MTFs expanded provider types, removed geographic restrictions, and more Most MTFs have been extended multiple times by Congress in years since

Some MTFs have been made permanent and a few have been discontinued MTFs will expire on March 31, 2025, if not extended or made permanent by Congress Current List of Medicare Telehealth Services

## MTFs Extended Through March 31, 2025

Originating Site	• Patient's home remains an eligible originating site for any telehealth service.
Provider Types	• Reimbursement continues for providers eligible to deliver telehealth and bill Medicare.
Acute Hospital Care at Home (AHCaH)	Reimbursement to hospitals with AHCaH programs continues.
Hospice Care	• Continue to use a telehealth visit for hospice recertifications.
In-Person	• Waive in-person visit requirements within 6-months of a tele-behavioral health visit and annually thereafter.
Audio-Only	• Audio-only eligible for reimbursement with some caveats (e.g., definition and codes).
FQHCs & RHCs (9 additional months)	• CMS noted to follow the 2025 PFS to provide non-mental health services and waive in-person visit requirement for mental health services to end of 2025.

Note: First dollar coverage of High Deductible Health Plans – Health Savings Accounts were not extended


