

Health Insurance Coverage: ACA Marketplace Center for Rural Health



Arizona enrolled a record 423,025 in ACA Marketplace in 2025

If ACA Marketplace subsidies are allowed to expire in Dec. 2025

>150,000 Arizonans could lose coverage

Due to doubling to tripling of premium costs in Arizona

Health Insurance Coverage: Medicaid Cuts



Proposed Federal cuts to state Medicaid programs could trigger:

250,000 to 500,000 Arizonans losing AHCCCS coverage

Loss of Medicaid coverage due to redetermination + proposed **ACA Marketplace + Medicaid cuts** could double the uninsured in Arizona from 750,000 individuals (10% AZ pop.) in 2025 to:

> 1,500,000 Arizona uninsured by 2027-28



Federal Medical Assistance Percentage (FMAP) And Arizona's Medicaid Program = AHCCCS



Medicaid is a federal - state program, at least 50% of costs are covered federally FMAP based on state's per capita income over 3yrs, if state pci<U.S., FMAP higher Arizona 2025 FMAP is 64.34%, multiplier \$1.80 (for \$1.00 AZ pays, fed pays \$1.80)

At Risk: Enhanced FMAP to 90% to Expand Coverage in Arizona

In 2014, AZ restored Prop 204 eligibility to 100% FPL (413,289 enrolled 5/1/25) And AZ expanded AHCCCS eligibility to 138% FPL (62,799 enrolled as of 5/1/25) Thus 476,088¹ enrollees @ 90% FMAP, if cut to <80%, could lose coverage

Summary: loss of Medicaid + Marketplace enrollment effects on Arizona

- 1) 250,000 to 500,000 Arizonans could lose Medicaid coverage
- 2) 150,000 Arizonans could lose ACA Marketplace coverage
- 3) 1,500,000 Arizonans could be uninsured by 2027-28



Summary: loss of Medicaid + Marketplace enrollment effects on Arizona

- 4) Arizona Medicaid & Marketplace insurers (BCBS, United) lose 400 to 600,000 enrollees (on top of >525,000 AHCCCS lost 3/1/23 to 5/1/25).
- 5) Hospitals, clinics, physicians shoulder higher charity care costs rural hospitals close
- 6) Emergency departments see a surge of uninsured who cannot find / afford primary, preventive and specialty care



Daniel Derksen, MD, is the University of Arizona Health Sciences Associate Vice President for Rural Health Workforce Development Initiatives. He is a Professor in the Zuckerman College of Public Health with joint appointments in the Colleges of Medicine and Nursing. He directs the Arizona Center for Rural Health (AzCRH) and principal investigator (PI) for the state and federally designated and funded State Office of Rural Health, and PI for the Health Resources & Services Administration (HRSA) Medicare Rural Hospital Flexibility (Flex) Program and Flex EMS Supplement.

His current activities include informing legislative, regulatory and program policy to improve access to health care and health insurance coverage; developing, implementing and evaluating community based experiential health professions training sites; expanding existing and creating new primary care graduate medical education (GME) residency sites in rural Arizona; and working to assure a well-trained and distributed health workforce to meet the health needs of all Arizonans.
