A. Personal Statement

I have 37 years of faculty experiences in applied health policy, outcomes, education, health workforce development and translational research that qualify me to conduct, analyze, publish and disseminate research; use these to inform the public, health providers and policymakers at the local, state and federal levels; and engage individuals and communities to develop and implement programs and initiatives to address unmet health needs in rural and urban underserved areas and populations.

As an example, CMS funded me in my role as Director of the New Mexico (NM) Office of Health Care Reform to establish NM's Affordable Care Act state health insurance marketplace, now titled now titled BeWellnm. It now has more than 56,000 enrollees. I engaged advocates, institutions, insurers, providers, consumers and stakeholders in the process. Currently I direct the University of Arizona Center for Rural Health (AzCRH) and serve as senior advisor for the Arizona Area Health Education Center (AzAHEC) Program in my role as Associate Vice President in the Office of the Senior Vice President for Health Sciences.

I have been principal investigator (PI) of state, federal, private foundation and other grant awards of over \$100 million over my 37-year academic career, \$48M over 25 years as faculty at the University of New Mexico (UNM), and \$55M over 12 years as a professor at the University of Arizona (U of A). I served as PI of the 2015-18 CMS Navigator program and as an AzCRH subawardee with the Arizona Alliance for Community Health Centers (AACHC) since then. I have served as PI of two state and federally designated and funded grant programs - the Arizona State Office of Rural Health (AzSORH) since 2013, funded by the State of Arizona and the Health Resources and Services Administration (HRSA) via a 3:1 state:federal match, and the AzAHEC Program (PI from 2020-23) funded by HRSA and the State of Arizona via a 1:1 state:federal match.

I have served as PI for the HRSA Rural Hospital Flexibility Program since 2013, the HRSA Flex EMS Supplement (2019-24) and HRSA Small Rural Hospital Improvement Program (SHIP, 2013-18). Through our AzSORH, AzFlex and other programs, I work closely with Arizona's 17 critical access hospitals (CAHs), 55 rural health clinics (RHCs) 32 of which are affiliated with Arizona critical access hospitals (CAHs), 44 Indian Health Service (IHS, n=16) and Tribal-operated (P.L. 638 Self-determination, n=28) clinics and hospitals, and the 26 community health center systems that operate 175 federally qualified health center (FQHC) sites.

I work closely with the Arizona Department of Health Services (ADHS) via Interagency Services Agreements (ISA's) on federal initiatives that are housed in AzCRH. These ISA's have included the Centers for Disease Control and Prevention (CDC) Overdose Data to Action (OD2A) and COVID Disparities (2021-23) initiatives, the Substance Abuse and Mental Health Services Administration (SAMHSA) Arizona First Responder Comprehensive Pain and Addiction (FR-CARA, 2017-22) Act and Medication Assisted Treatment (MAT, 2019-21) Mentor initiatives to train first responders to administer naloxone to reverse opioid overdoses to save lives and have licensed health providers mentor new MAT providers to treat those with opioid related substance use disorders. This is important in Arizona because it shares 373 miles of border with Mexico, with illicit drugs laced with fentanyl that contribute to horrific morbidity and mortality consequences in rural and urban areas of the state.

In my role as Associate Vice President (VP) in the Office of the Senior VP for Health Sciences at the University of Arizona, I now serve as senior advisor for the state and federally funded and designated Arizona Area Health Education Center (AHEC) Program working with the six AHEC Regional Centers in Arizona and the nine Rural Health Professions Programs (RHPPs) in collaboration with Arizona's three public universities with health professions training programs - University of Arizona (U of A), Arizona State University (ASU) and Northern Arizona University (NAU). The newest Arizona AHEC Regional Center – the American Indian Health AHEC – was created by state statute, began operations in September 2022 using state AHEC funding, and awarded matching federal HRSA funding in 2024.

From 07/01/2023 through 06/30/2024 the AzAHEC Program in conjunction with the six established AzAHEC Regional Centers and nine RHPPs provided 1.945 health professional students and trainees 4.028 communitybased, experiential training (CBET) field experiences across Arizona for 570,351 learner contact hours. The AzAHEC Program administers a \$5 million State of Arizona one time, non-lapsing appropriation to expand existing and create new primary care graduate medical education (GME) residency programs in collaboration with Arizona federally qualified health centers (FQHCs), critical access hospitals (CAHs), rural health clinics (RHCs) and tribal operated (P.L. 638 Indian Self-Determination) clinics and hospitals. In December 2024, the Halle Foundation awarded \$2 million to the U of A to expand on the state appropriation to create new primary care GME programs emphasizing rural, tribal, border and urban underserved areas.

I collect, analyze, report, and translate data to enhance community engagement and thereby improve health insurance coverage, use data to create health professional education programs to address unmet health needs including rural primary care residencies – graduate medical education (GME), physician assistant, nurse midwife, physical therapy and other health professions programs, and address sustained safety net financing and access to quality health care, emphasizing interprofessional, team and enhanced community-based service-learning models in rural and urban underserved areas.

As faculty at UNM and U of A I have chaired 47 statewide conferences and given 530 invited lectures. Since I returned to U of A in 2012, I have been interviewed, published, broadcasted, and disseminated in 467 print, radio, television, and social media venues. Our Center for Rural Health data visualizations, policy briefs, and educational materials are often cited in these multimedia venues – expanding our reach to provide trusted information to the public.
